






What is the Bima Sakhi Program?











What are the benefits of becoming a Bima Sakhi?



- Stipend for Three Years: ₹7,000 in the 1st year, ₹6,000 in the 2nd year, ₹5,000 in the 3rd year.
- Commission-Based Earnings: The more business you bring, the higher your earnings.
- Flexible Work Hours: Balance work with other personal responsibilities.
- Community Respect: Be a trusted advisor in your locality.
- Training & Certification: Gain professional skills through IRDAI-approved training.

What are the eligibility criteria for joining?

G

Qualification: 10th Pass.

5

Age: 18 years and above.

Who Can Join: Unemployed women looking to achieve financial independence.

Fees: A nominal fee of ₹860/- for registration, training certificate, book, and exam.

How do I enroll as a Bima Sakhi?

 Visit your local LIC office or contact a development officer.

 Your details will be registered on the LIC/IRDAI website, and a unique reference number will be generated.









Is there any training provided?

Yes, mandatory **25 hours of training (IC-38)** is conducted through LIC/IRDAI-approved training centers. This training equips you with the necessary knowledge to succeed in the program.

What about the examination?

- The exam is a 1-hour online objective MCQ test conducted by NSE-IT.
- Good News: Minimum passing marks are just 15 out of 50!
- Upon passing, you will receive an appointment letter and agency number issued by LIC of India. ₹6,000/month.










What are the monthly targets and commissions?



Month 5–8: 2 Lives per month, commission ₹4,000/month.

Month 9–12: 3 Lives per month, commission ₹6,000/month.

Annual Target: 24 Lives and Rs 48000 Commision without Bonus

Can I earn more than the stipend and targets?

Absolutely! Commissions are based on the business you generate. The more policies you sell, the higher your commission. There are no limits to your earnings.








What happens after passing the exam?


Once you qualify:
